TERMS OF USE FOR USE IN DIGITAL WALLET

The following terms and conditions (these “Terms of Use”) govern your use of ALINE Card by ADP Visa Prepaid Card issued by Central National Bank, Enid, Oklahoma, Member FDIC (the “Bank”) under which ADP, LLC (and its affiliates) (“ADP”) is the program manager (the “ALINE Card”), through a digital wallet, including Apple Pay, Android Pay or any other digital payment service provider, and related features (“Mobile Wallet Card”) the Bank makes available to you. These Terms of Use are a legal agreement between you, the Bank and ADP (“us”, “we” or “our”). They apply to you and anyone else you authorize to use your Mobile Wallet Card(s).

If you choose text messages as your verification method, you consent to receive text messages at the mobile phone number you have on file with us for this card. Text messages may be transmitted using auto-dialer technology. Your usual wireless carrier fees may apply.

We do not currently charge any fee for creating or using your Mobile Wallet Card, you will be responsible for all fees that may be imposed by other parties in connection with your use (such as but not exclusive of data usage or text messaging charges imposed on you by your wireless carrier) and be subject to any restrictions those third parties may impose.

You understand and acknowledge that we may be required to provide information related to our participation in a digital payment service provider's program which such service provider may use for purposes such as performing service provider's obligations, exercising its rights, and improving its service platform.

We reserve the right for any reason to discontinue offering or supporting any Mobile Wallet Card or to not participate or terminate participation in a digital payment service provider's program. Except as otherwise required by applicable law, we may block, restrict, suspend or terminate your use of any Mobile Wallet Card at any time without notice and for any reason, including if you violate these Terms of Use or any Cardholder Agreement, if we suspect fraudulent activity, or as a result of the cancellation or suspension of your ALINE Card account. You agree that we will not be liable to you or any third party for any block, suspension, cancellation or termination of your use of any Mobile Wallet Card.
